Ula Furgal

Dr Ula Furgał is a Lecturer in Intellectual Property and Information Law at the University of Glasgow Law School. She is a member of the CREATe Centre, a centre for copyright and new business models in the creative economy, working on projects concerning platform regulation and reversion rights. Ula is an editor of the Copyright Directive implementation resource page and a managing editor of the CREATe Working Paper series. She completed her PhD exploring the effects of a new press publishers' right on the EU copyright framework at the European University Institute in Florence, Italy. She holds LLM in Intellectual Property Law from Trinity College Dublin, and a Masters in Law and a Bachelor in Public Administration from Jagiellonian University (Krakow, Poland). Ula's research focuses on copyright, information law and media studies.

Marco Giorello

Marco Giorello has been the Head of Unit for Copyright in the European Commission (DG CONNECT) since 2017. He has been working in Copyright since 2011. Italian and lawyer by training, he has worked for the European Commission for more than 20 years, covering numerous areas of the European Internal Market policy. He has been directly involved in the planning and negotiations of the Copyright reform, including the Directive on Copyright in the Digital Single Market. Prior to joining the European Commission, he worked for an Italian law firm and lectured on EU Law. He holds an LLM in European Law awarded by the College of Europe in Bruges (1998).





Pauline Durand-Viaille

Originally from Paris, France, Pauline has worked in film distribution and international sales. She joined FERA from her previous position as Deputy Manager in charge of European Affairs at La Société des réalisateurs de films (SRF), where she worked for five years. She is the Chief Executive of FERA since February 2014.



Born in 1974 in Białystok, Poland, Tomasz Frankowski is a former Polish national footballer. He played in several football clubs such as Jagiellonia Białystok, Wisła Kraków, RC de Strasbourg, Potiers, Martigues, Elche, Nagoya Grampus Eight, Wolverhampton Wanderers, CD Tenerife and Chicago Fire. He is the third most successful goal scorer in Polish football league history. After his successful football career, he became a member of the Civic Platform. Following his election to the European Parliament in 2019, he is a member of the Committee on Culture and Education and the Committee on Transport and Tourism. He was appointed a shadow rapporteur from the EPP Group on the Creative Europe Programme for 2021-2027.

Iban Garcia del Blanco

Ibán García del Blanco, 42, was born in León, Spain. In 2003, he started a full-time career in politics, serving from local to national administration: City Councillor (2003-2011), member of the Provincial Council (2011-2012), and member of the Spanish Senate (2012-2015) where he served as the second Vice President of the Health and Social Affairs Committee. Within his political party, the Spanish Socialist Workers' Party (PSOE), García del Blanco is a member of the Federal Executive Commission in charge of Culture and Sports. In 2018, García del Blanco was appointed President of Acción Cultural Española (AC/E), an agency providing public support to the promotion of culture, both in Spain and overseas. He held this position until his recent election as an S&D member of the European Parliament, where he serves as Vice President of the Legal Affairs Committee and he is a substitute member in the Committee of Culture.

Aurélie Champagne

Aurélie Champagne is the Counsellor for Culture, Audiovisual, Media and Copyright at the French Permanent Representation to the EU. She currently chairs the Council's Audiovisual and Media and Copyright Working Parties, under the Presidency of the Council of the European Union. She has worked for ten years in the field of European affairs, both in the private and public sectors, including six years at the French Ministry of Culture as a policy officer for digital issues and competition law.





Anselm Kreuzer

Anselm Kreuzer is a German composer of music for television, film and other audio visual media. He has written numerous title tunes for TV shows, score music for several TV series and a huge oeuvre of production music, also running an independent production music library. He has been elected as a board member of ECSA in 2022. Furthermore, he is a board member of Composers Club Germany since 2014, leader of the audio working group in the Cologne-based media association Eyes & Ears of Europe since 2003, deputy in the Works Committee of GEMA since 2015, guest lecturer at several universities and branch events as well as author of two monographs on film music.

Janine Lorente

Janine dedicated her professional career to the defense and promotion of authors' rights, in particular the rights of screenwriters and directors to receive a fair share of the revenues generated by the works they create. She carried out international projects as an executive for authors organizations in France, USA and Spain. And for several years now, as a consultant, she has been advising and accompanying CMOs, writers' and directors' Guilds, their regional federations in the US, EU, UK, South America, or Australia. Always with the same goal: improving the contractual and legislative rights of authors.
